Church-Based Mental Health Services (CBMHS) provides free and sliding-scale professional mental health counseling to individuals at seven church locations in central New Jersey. CBMHS strives to reduce the barriers to high-quality mental health care, including cost and the stigma that often accompanies seeking mental health care. Churches are places that many people feel comfortable seeking and receiving help. New in 2016. Estimated 15 people benefitted from program.
